Presidential Wrap Up for 2009**

**July 2009**

Business Professional Women/USA merged with Business Professional Women's Foundation effective July 1, 2009.

July 31 – August 1 Members Sue Banks, Jo Ann Orr, and Venita Garvin Valdez traveled to St. Louis Missouri to celebrate the 90<sup>th</sup> year anniversary of Business and Professional Women USA. Close to 200 BPW members were in attendance with a representation of 28 state federations.

**August 2009**

BPW/FL Members, Dr. Sheila Barry-Oliver and Venita Garvin Valdez traveled to Washington, DC for a two day board retreat with the BPW Foundation. Dr. Barry-Oliver a former chair of BPW Foundation was elected to serve again as a National Board of Trustee, appointed to chair the Research and Education Committee and appointed as a committee member of the governance committee. Garvin Valdez elected to the BPW Foundation Board of Trustees July 1 was voted to serve as Secretary of BPW Foundation, appointed Chair of the Development Committee, and appointed as a committee member of the governance committee.



**September 2009**

The Moving BPW Florida Forward Task Force met in September to review progress to date since the task force was assembled in March 2009. The areas of focus for the task force have been membership, finance and governance. It was agreed that continuous examination in these areas was required as BPW Florida moves forward now that BPW/USA and BPW Foundation has merged. One of the primary concerns is keeping the BPW Florida membership at large informed on changes and improvements as they occur. It was agreed that the use of a variety of communication methods will have to be utilized. Also examination took place of the results of the bylaws survey that was conducted and identification of areas of the bylaws that will require attention in the coming year. The areas of focus included BPW Florida web site, communication of technology information to local organizations using the BPW Florida web site, membership processing, and review and updating the content of various signature programs bringing them under the Leadership Institute umbrella in order to keep the content of the programs current. Thanks to Bobbie Jean Williams, Chair of the Moving BPW Florida Forward Task Force and BPW member of Tampa Bay for her leadership in chairing this committee and host of BPW members throughout the state that are serving on this committee!

A special called meeting was held September 19, 2009 of the BPW Florida membership to vote on if BPW/Florida would sign the licensing agreement with BPW Foundation. BPW/FL voted favorably to sign the licensing agreement with BPW Foundation. BPW Florida President, Venita Garvin Valdez signed the licensing agreement during the special called meeting.



## **October 2009**

Sixty BPW Florida members and guests climbed the mountain of Mt. Dora, Florida. BPW/Florida Fall Conference 2009 was held in Mount Dora, Florida hosted by North Lake, South Lake and Orlando BPW local organizations. Thanks to Conference Chairs, Shirley Grantham and Nancy Hurlbert and host of committee members for a job well done on the conference. Special items addressed during Fall Conference, approval of budget amendment for the state budget 2009-2010 and bylaw revisions.

The Board of County Commissioners of Lake County, Florida presented BPW Florida a proclamation recognizing the month of October as Domestic Violence Awareness Month. The proclamation was presented to BPW Florida President Venita Garvin Valdez from Nancy Hurlbert, Past State President of BPW Florida and Fall Conference 2009 Co-Conference Chair during opening ceremony at Fall Conference 2009.

A committee of BPW Florida members assembled to begin to redesign the BPW signature programs of Individual Development, Young Careerist, and Women in Transition.

## **November 2009**

Ground breaking ceremony conducted on November 20 for the new scholarship house being built on St. Pete College in St. Petersburg, Florida.
